REGISTRATION OF SUPPLIERS ON ELECTRONIC VOUCHER MODALITY OF INPUTS SUPPLY UNDER THE FARMER INPUT SUPPORT PROGRAMME (FISP) 2024/2025 FARMING SEASON

The Government of the Republic of Zambia is implementing the electronic voucher (e-voucher) modality during the 2024/25 farming season under the Farmer Input Support Programme (FISP). The programme is targeting 739,266 beneficiary farmers in the 74 districts tabulated below.

To this effect, the Ministry of Agriculture invites bona fide input suppliers of fertilizer, seed, agrochemicals, veterinary drugs, aquaculture inputs, small-scale mechanization and irrigation equipment/implements to register as suppliers.

Eligibility Criteria for Input Suppliers

Firms wishing to register as suppliers under e-voucher should be locally registered manufacturers, wholesalers/distributors and agro dealers of fertilizer, seed, agrochemicals, veterinary drugs, aquaculture inputs, small-scale mechanization and irrigation, equipment and implements. Firms should be able to satisfy the selection criteria below:

Selection Criteria for Input Manufacturers, Distributors and Retailer/Agro-dealers

2.	Technical requirements	Eligible supplier must meet specific requirements (whichever applicable and where available). Agro-chemical suppliers: <ul style="list-style-type: none"> • Pesticide and toxic substance licence-ZEMA licence. Distributors/Agro dealers: <ul style="list-style-type: none"> • Seed Sellers Licence obtained from Ministry of Agriculture. Veterinary suppliers: <ul style="list-style-type: none"> • ZAMRA certificate and ZEMA certificate (Where applicable).
3.	Other requirements	Suppliers must meet the following eligibility criteria:	<ul style="list-style-type: none"> • Must have physical presence or agency in areas they want to supply. (Traceability) • Commitment to timely delivery of inputs. • Capacity to transact through the ZIAMIS platform. • Must be willing to enter into service level agreements that define expected performance and standards.
